Western Classes may be divided between Gaited and non Gaited if entries warrant. All classes may be divided into Junior, Amateur and Open divisions if entries warrant, at the discretion of the management.

• ***FEES***

\$25/class member, \$35/class non member

\$20 facility/secretary fee per horse/rider combination.

Late fee of \$10/class if not in secretary's hand by closing date.

Mail fee \$5 to have scored test(s) and ribbon(s) mailed to you after the show.

CLOSING DATE March 20, 2020

****REFUNDS:** No refunds will be issued after closing date. Credit for classes may be issued that may be used at BDCTA shows for one year. Any cancellation by show management will result in full refund.

NON-COMPETING HORSES: Will be permitted on show premises. Please inform the receiving secretary and provide a \$15 fee and a negative Coggins test copy for each non-competing horse.

ARENAS: Dressage arenas will be on sand and grass, as needed. Jumping will be on grass. Warm-up on grass.

AWARDS: Ribbons will be awarded for places 1-6 in each class.

STABLING: Limited stalls may be available. Contact Pam Abdullah at El Gezira Riding Academy, 205-907-8300.

TRAILER PARKING: In designated areas only—look for signs.

ATTIRE: No coats required. Braiding optional. Tack and apparel should meet USEF guidelines, with accommodations for western, gaited and driven dressage participants as detailed on the website. All horses should be flat shod. No pads allowed except those for therapeutic purposes.

HELMETS: BDCTA follows USDF/USEA/USEF rules for helmet use. *Helmets are required for all riders at all times while mounted on a horse.*

CONCESSIONS: will not be available at this show. Please plan accordingly.

VOLUNTEERS: BDCTA shows are run by volunteers for our members and competitors, and BDCTA members must earn a minimum number of hours to qualify for year-end awards. **As you know, it takes a lot of help to put on a great show!** If you, a friend, or a member of your group can spare a few hours to help, **PLEASE let us know.**

MISCELLANEOUS: NO DOGS ALLOWED. The show will be conducted following USEF/USDF/USEA rules, with NWHHA rules for the gaited divisions, WDAA rules for Western dressage. Management reserves the right to combine classes or limit entries or cancel classes with fewer than 3 entries.

MEMBERSHIP: If you are not currently a BDCTA member, you may join with entry. **Please include a membership form and a separate check for membership fees. Membership cannot be processed otherwise.**

Jumper Rounds: Table II sec A “Timed First Round”. Pre-registration is encouraged. Entry for show jumping classes is allowed the day of the show must be done with the show secretary (NOT at the in gate). An open check is required. **ALL SHOW JUMPING ROUNDS MUST BE ENTERED NO LATER 11:00 a.m. at the Secretary’s desk.**

RIDE TIMES AVAILABLE ON THE BDCTA WEBSITE Thursday PM, March 26, 2020.

CLASSES/DIVISIONS: may be combined, split or dropped at the organizers’ discretion due to entries.

I agree in consideration for my participation in a Birmingham Dressage and Combined Training Association, Inc (BDCTA) sponsored event to the following:

- I agree that I choose to participate voluntarily in the competition or event with my horse as a rider, driver, handler, lessee, owner, agent, coach, trainer, or as a parent or guardian of a junior exhibitor. I am fully aware and acknowledge that horse sports and the Competition Event involves inherent dangerous risks of loss, and serious bodily injury, including, but not limited to, head injuries, trauma, broken bones, pain and suffering, or death ("Harm").
- I agree to release, indemnify and hold harmless the BDCTA and the Show/Event Location, their officers, officials, directors, employees, agents, and volunteers from claims for Harm to me or my horse, and for claims made by others for any Harm caused by me or my horse at the Competition or Event.
- I agree to expressly assume all risks of Harm to me or my horse, including any Harm resulting from the negligence of the BDCTA or the Competition /Event Location owners, officers, etc.
- If I am a parent or guardian of a junior exhibitor, I consent to the minor child's participation in the Competition/Event and agree to assume all of the obligations of the release on the child's behalf.
